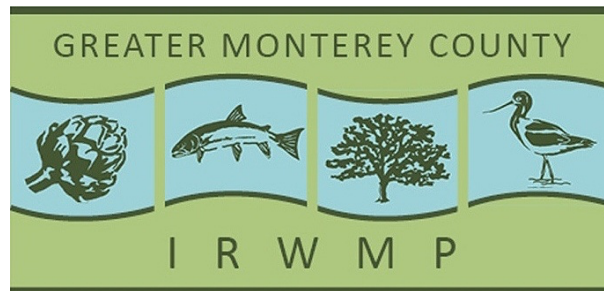

Acknowledgements

This effort in the Salinas Valley was a group effort not only in its execution, but in its conceptualization. After early efforts by then-Assemblymember Luis Alejo (D - Salinas) to fund the project through legislation were stymied by a then-still languishing economy, growing awareness of the impacts of California's historic drought and an increasingly vocal chorus of environmental justice advocates with the Environmental Justice Coalition for Water continued to push for action with Mr. Alejo. These efforts successfully achieved inclusion of funds in the Budget Act of 2014, so that work could begin, and, again, in the Budget Act of 2016, so that work could be completed.

The planning funds from the State were further complemented by interim emergency drought funding for replacement bottled water from both the State Water Resources Control Board and the Central Coast Regional Water Quality Control Board and direct financial and in-kind donations of professional services from the Community Engineering Corps, itself funded by the United States Department of Agriculture.
